BATTERY PRODUCTS EXPO OPPORTUNITY NAATBatt

2022 will dedicate a 5,390 square foot ballroom at the Wigwam Resort as the Battery Products Expo Hall. All breakfasts, breaks and networking receptions during the NAATBatt 2022 meeting will be held in the Expo Hall. The Expo Hall will be open during the NAATBatt 2022 general sessions.

NAATBatt is offering the opportunity for companies to purchase a 10 x 10 space in the Exhibit Hall to exhibit products and distribute literature. Exhibit space includes a draped table, two chairs and waste basket. Exhibitors may display signage, devices and literature subject to the hotel's regulations. Exhibitors will be acknowledged in the NAATBatt 2022 meeting program.

The cost of an exhibit space in the Expo Hall is \$3,500, which includes the cost of the exhibit space and one conference registration (a value of up to \$2,295). The net cost of an exhibit space at NAATBatt 2022 can be less than \$1,400—a bargain compared to other industry conferences. In addition, NAATBatt will allow all other employees of an exhibiting company to register for NAATBatt 2022 at the rate of \$1,500 per person. That is a potential savings of up to \$695 per registrant.

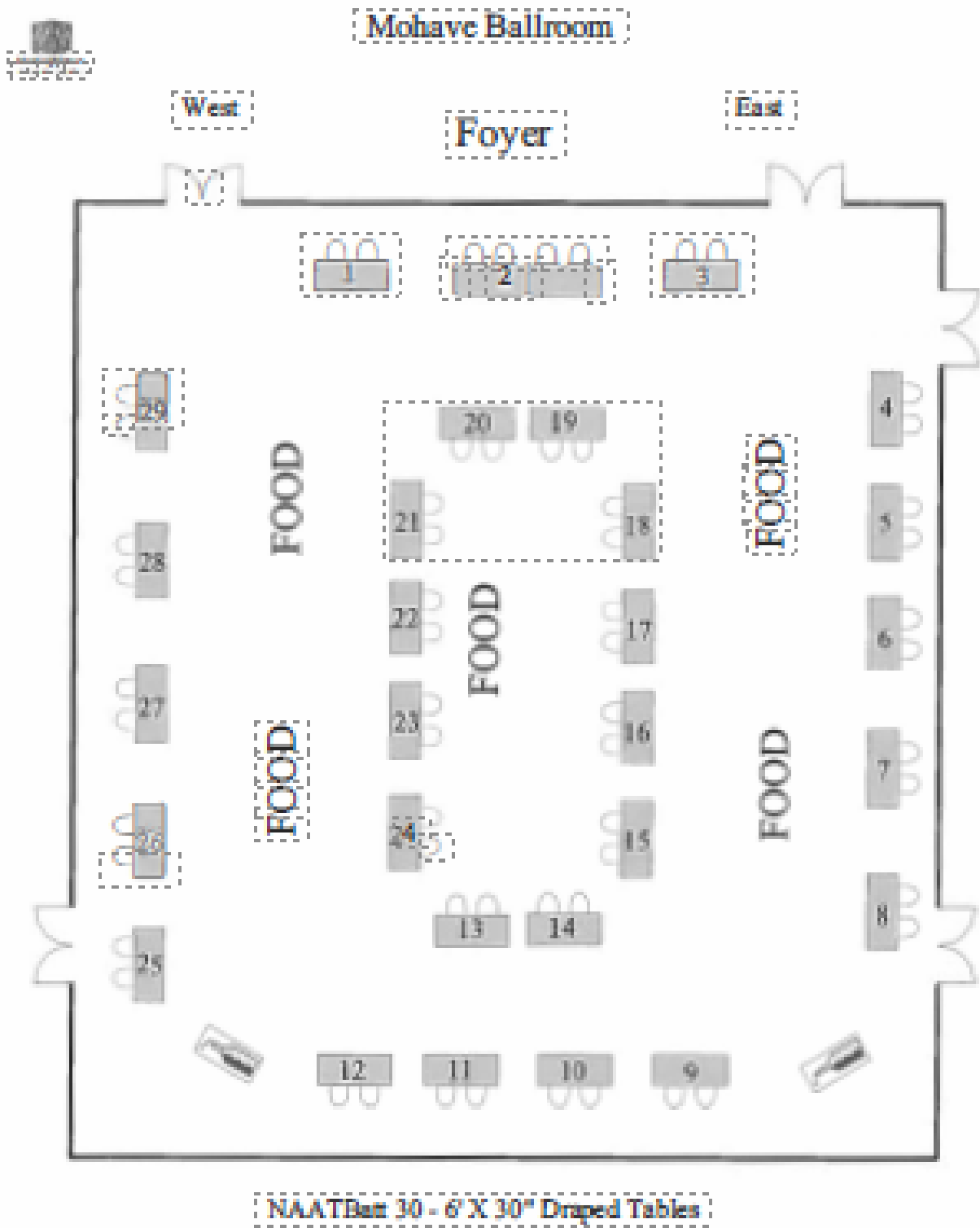
